## Update on the execution of the buy-back programme

**Padua, April 23<sup>th</sup>, 2019** – SIT S.p.a. (“SIT”, or the “Company”), listed on the MTA market, with reference to the buy-back programme approved by the shareholders on April 26<sup>th</sup> 2018, and launched on November 5<sup>th</sup>, 2018, informs that in the period between April 15<sup>th</sup>, 2019, and April 19<sup>th</sup>, 2019, acquired no. 1.100 SIT’s ordinary shares at an average unit price of EUR 8,8896 per share, for a total amount of EUR 9.778,59.
