Update on the execution of the buy-back programme

Padua, March 7th, 2022 – SIT S.p.a. (“SIT”, or the “Company”), listed on the Euronext Milan market (ex MTA market), with reference to the buy-back programme approved by the shareholders on April 29th, 2021, and launched on the same date, informs that in the period between February 28th, 2022, and March 4th, 2022, acquired n. 8.000 SIT’s ordinary shares at an average unit price of EUR 8,1788 per share, for a total amount of EUR 65.430,25.
