Update on the execution of the buy-back programme

Padua, July 12th, 2022 – SIT S.p.a. (“SIT”, or the “Company”), listed on the Euronext Milan market (ex MTA market), with reference to the buy-back programme approved by the shareholders on April 29th, 2022 and launched with a resolution of the Board of Directors of May 11th, 2022, informs that in the period between July 4th, 2022, and July 8th, 2022, acquired n. 2.200 SIT’s ordinary shares at an average unit price of EUR 6,8618 per share, for a total amount of EUR 15.095,90.
